

**MICHIGAN DUCKS UNLIMITED**  
**2025 SPONSOR PRINT & ARTIST OF THE YEAR COMPETITION**

Please read carefully. By entering this competition you acknowledge that you have read and will comply with the rules, reproduction rights, participation agreement, and the liability waiver.

**RULES:**

Failure to abide by the following format rules and participation agreement will be cause for disqualification from the 2025 sponsor artist of the year competition.

1. The artist subject matter is limited to 2 choices. Choose only one of the following:  
**Long-tailed Duck (formerly known as an Old Squaw) or a Canine Retriever, of any breed, in a waterfowl hunting scene.**
2. All artwork must be of the artist's own original creation and not have been reproduced in any format.
3. Artwork must be the following size: 10 inches wide by 7 inches tall.
4. Artwork must have been created within the last three years.
5. No signature or identifying mark may appear anywhere on the image. Please do not put your name on the back of the artwork. You will be designated a number on a random basis.
6. The artwork must be display ready with a foam core or suitable backboard and 2-inch-wide white mat should be affixed to the surface. Overall size will be 11 x 14.
7. Artists are free to utilize his or her own choice of medium.

**All artwork must be received by July 1, 2024.**
9. Judging format is as follows: If more than 15 paintings are entered, a panel of 5 judges shall make the initial juried selection. The top 15 finalists shall then be presented to the conference attendees who shall make a people's popular choice selection via secret ballot to choose the winner of the competition. If for any reason a State Leadership Conference cannot be held, the winner will be chosen through an online format.
10. In case of a tie the State Chairperson shall make the final selection. All judging decisions are final.
11. The winning artist shall make the painting available to Michigan Ducks Unlimited immediately following the contest in order that we may begin the process of printing. The painting will be returned to the artist for signing and must be promptly returned to the office or our printer.
12. The winning sponsor Artist from 2024 is ineligible to participate in the 2025 contest.
13. Only one entry per artist is allowed.
14. Photos of the first, second and third place paintings will be shared with all applicants and posted on Facebook Group sites associated with Duck Stamps or Ducks Unlimited.

**REPRODUCTION RIGHTS, PARTICIPATION AGREEMENT, AND LIABILITY WAIVER**

**REPRODUCTION RIGHTS:**

1. Artists will retain ownership of all original artwork. The winning artwork shall be held in possession of Michigan Ducks Unlimited during the duplication process and will be returned to the Artist after all prints have been produced. Reproduction rights of the image remain with Michigan Ducks Unlimited.
2. The artist agrees not to create for Ducks Unlimited, Inc., Michigan Ducks Unlimited or any other organizations or individuals a work of art so similar as to be readily interpreted as identical.
3. The artist hereby reaffirms that the entry is an original creation, neither copied nor duplicated from any previous entry, including but not limited to, original paintings, drawings in any medium, or published photographs.
4. The 2025 Michigan Ducks Unlimited Sponsor print shall consist of approximately 2500 prints with 3 color remarques. The artist will sign and number the print series.
5. The artist of the winning print will receive \$2500 and 50 prints for their personal use upon completion of all obligations mentioned pursuant to the release of the 2025 Sponsor Print Edition.

**PARTICIPATION AGREEMENT:**

1. The artist is hereby notified and does agree to the following without exception:
2. The artist shall pay an entry fee of \$50.00 to participate in the 2025 Michigan Ducks Unlimited Sponsor print contest.
3. The artist is responsible for shipping charges to the contest office.
4. The artist shall provide a reusable shipping container that meets all commercial shipping specifications both foreign and domestic.
